Project Name (File Number): Mallula-Dykes (SE-24-00010)

Owner: Dana Mallary & Jonathan Dykes; Jeff & Shelia Mallula; represented by Theo Leonard, P.E.

Location: The subject properties are parcels #952018 and #952019, approximately 900 feet Northwest of Roslyn, WA, in the SE ¼ of Section 7, Township 20, Range 15, in Kittitas County.

Proposal: The property owner is proposing a shared access driveway, individual driveways, and new residences on both lots. This will involve the removal of trees within the areas of the new accesses and residences, which will require an FPA permit from the Department of Natural Resources. A grading permit is also expected to be required by Kittitas County Public Works. The project is proposed on a site that is zoned Rural-5 within a Rural Residential Land Use designation.

A Mitigated Determination of Non-Significance (MDNS) is expected to be issued using the optional MDNS process under WAC 197-11-350. This may be the only opportunity to comment on the environmental impacts of this proposal. A copy of this subsequent threshold determination will be available to the public upon request.
