

Poulin Setback Variance
(AU-13-00002)


Pursuant to RCW 36.70B.130 and KCC 15A.06, notice is hereby given that Kittitas County Community Development Services granted approval for an application from Bruce Poulin, landowner, for a Structural Setback Variance from the required 25 foot front yard setback in the Forest and Range zone. The approval of this variance allows for a front yard setback of 20 feet from the west property line for the construction of a 16' x 24' garage. The site is located 14 miles northwest of the city of Cle Elum at 200 Mountain Home Lane, in a portion of Section 17, T21N, R13E, WM in Kittitas County, bearing Assessor's map number 21-13-17050-0052.

An appeal of this land use decision may be filed within 10 working days by submitting specific factual objections and a fee of \$500 to the Kittitas County Board of Commissioners at 205 West 5th, #108 Ellensburg, WA 98926. The appeal and deadline is 5:00 pm July 3, 2013.
