Thank you for the opportunity to comment on the above listed Application.

1. The fifteen foot setback requested, when in high snow load areas, can cause structural problems and disputes between neighbors (now and future) when snow continues to slide off a roof and build up on the property line. Building placement and the direction of roof pitch can all change how snow affects the neighboring property. I recommend a snow storage or removal plan be required of the architect or engineer designing the structure and added to the variance if approved.
