Hi Kelly,

I've spoken with Josh and below is our response.

1. Based on the updated site plan, it appears that the structure could be moved so that the corner of the residence is more than 1-ft from the property corner. Public Works is not supportive of a variance to allow 1-ft setback. Public Works' concern is related to future conditions where a 1-ft set back may become an issue. Cameron Curtis and Josh Fredrickson are both happy to meet with the applicant to talk through potential issues. In this situation Public Works would be comfortable with a minimum 5-ft setback, but the applicant should make every effort to increase this set back distance as much as possible.

Hi Kelly –

Cameron Curtis provided comment C, so I am looping Cameron and Josh into this e-mail. The concern identified in comment C is that a 1 foot setback against the property line is not sufficient given potential conflict with future development of the private road intersection. Based on the information provided in the original application, PW opposed a variance which allowed a building to be placed within a foot of the property line. Josh or Cameron will need to review the additional information provided by the applicant (I've attached the updated site plan and the applicant's response to comments) to determine if their concerns have been addressed.
