NOTICE IS HEREBY given that Orlando & Leanna Maynes, landowners, submitted a Setback Variance application on January 21, 2021 pursuant to Kittitas County Code 17.84 on approximately 0.54 acres of land zoned Rural 5. The proposal requests a 10-foot reduction from the 25-foot front lot line setback requirement in KCC 17.30A, for the construction of a residence, which would result in a 15-foot front lot line structural setback if the variance is approved. The subject property is parcel # 956186 located on Hermitage Drive, approximately 0.3 miles from the intersection of Hermitage Drive and Gold Course Road in Cle Elum, WA. In Section 35, Township 20, Range 14. Map number 20-14-35059-0006.

A Notice of Decision will be published once a decision is made. Appeals to an administrative land use decision may be filed within 10 working days with Community Development Services as outlined in Chapter 15A.07 of the Kittitas County Code. The current appeal fee is \$1540, however you are encouraged to verify fee prior to filing of an appeal.
