CORNER OF THE N.W. 1/4 OF THE S.E. 1/4 OF SECTION 34, T21N, R14E.W., thence N27°00'W 341 feet; thence N 5°45'E 229 feet; thence N16°50'E 593 feet; thence N30°W 870 feet; thence N20°47'W 800 feet; thence N.40°34'W 175' to the N.W. corner of the S.W. 1/4 of N.E. 1/4 of said section.

and ending at as stated above, the whole distance being about 3/5ths miles, said road being numbered _____.

Your petitioners respectfully represent and allege that the road is useless as a part of the general road system and the public will be benefited by its vacation, and that all of your petitioners are freeholders residing in said County in the vicinity of said road; therefore your petitioners pray for the vacation of said road, as provided by law.

WHEREAS a petition presented to the Board of County Commissioners of Kittitas County asks for the vacation of portions of Cle Elum and Trout Lake Road No. 52, and WHEREAS it appears that the said portions of County Road No. 52 are no longer needed as a part of the county road system, since a new road has been constructed,

NOW, THEREFORE, BE IT RESOLVED that it is the intention of the Board to vacate and abandon the said portions of Cle Elum and Trout Lake Road No. 52, described as follows:

All of the Cle Elum and Trout Lake Road No. 52 from its intersection with the 5th parallel (south line of Section 34, T. 21 N., R. 14 E.W.M.) northerly to the north line of Sec. 16, T. 22 N., R. 14 E.W.M., Kittitas County, Washington.

EXCEPT those portions of said road occupied by the present county road known as

the "Salmon La Sac" Road.

BE IT FURTHER RESOLVED that the County Road Engineer be hereby directed to make an examination of said road and report on the vacation and abandonment thereof, and that the hearing on said proposed vacation be had on the 18th day of July, 1960, at the hour of 11 o'clock A.M., at the office of the Board of County Commissioners at Ellensburg, Washington.
