Mr. Harding has been booked into the Kittitas County Corrections Center on several different occasions while the Kittitas County Corrections Center was charging a booking fee.

On November 19, 2001 Mr. Harding was booked into jail and was charged a \$10.00 booking fee and it was collected in full.

On February 25, 2002 Mr. Harding was booked into jail and was charged a \$10.00 booking fee and it was collected in full.

On May 5, 2002 Mr. Harding was booked into jail and was charged a \$10.00 booking fee and \$4.10 was collected. On June 8, 2002 \$5.90 was turned over to collections.

On February 11, 2003 Mr. Harding was booked into jail and was charged a \$10.00 booking fee and \$0.58 was collected. On March 30, 2003 \$9.42 was turned over to collections.

On April 23, 2003 Mr. Harding was booked into jail and was charged a \$10.00 booking fee and it was collected in full.

On November 16, 2003 Mr. Harding was booked into jail and was charged a \$32.50 booking fee and nothing was collected. On December 8, 2003 \$32.50 was turned over to collections.

On May 26, 2004 Mr. Harding was booked into jail and was charged a \$32.50 booking fee and \$5.52 was collected. On August 16, 2004 \$26.98 was turned over to collections.

The total amount that was sent to collections was \$74.80 and the county has not collected anything on that amount. Collections show this debt in bankruptcy.

The total amount that Kittitas County has collected on Mr. Harding booking fees is \$40.20.

Attached to this letter are Mr. Harding's Resident Receivable Report and his collection account information.

If this claim is not subject to the statute of limitations, I would recommend the County reimburse Mr. Harding for the actual funds collected from him \$40.20.
