Improvements to NF Teanaway Road will extend from Milepost 0.00 to Milepost 2.56. Washington State Department of Commerce will administer the funds.

The project will be formally added to the annual construction plan.

NF Teanaway Road will be overlain with hot-mix asphalt. The road and shoulders will be widened. Culverts will be extended. Guardrail will be added as necessary.





