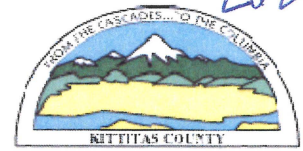

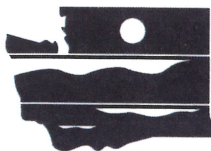

INTERAGENCY AGREEMENT NO. C1400161

BETWEEN THE

STATE OF WASHINGTON DEPARTMENT OF ECOLOGY

AND

KITTITAS COUNTY PUBLIC HEALTH DEPARTMENT

PURPOSE: To amend the Agreement between the Department of Ecology, hereinafter referred to as 'ECOLOGY' and, Kittitas County Public Health Department, hereinafter referred to as 'KCPHD' or 'CONTRACTOR'.
