Dear Mrs. Buchholz:

Upon review of the above permit application, I have the following comments/requirements;

- A separate Event Permit along with an appropriate site plan is required for this event. A fee of \$165.00 shall be obtained by the Fire Marshal's Office Event Permit application. The applicant has already paid for the permit in full.
- Parking shall be such that fire apparatus access is maintained at all times with a minimum driving width of 20 feet between rows of parked cars.
- The fire apparatus access roads shall remain free from obstructions.
- The access roads in the camper/tent camping area shall be a minimum of 20' wide.
- All vendors shall have a minimum of 2A-10B:C fire extinguishers readily available for use.
 Please ensure my staff and I have full access to inspect these vendors. Any LPG tank shall be secured to prevent displacement.
- Please be aware of general trip hazards from extension cords, tent tie-downs, etc. Also, extension cords may not be piggy-backed/daisy-chained together.
- Any generator located on site shall be inspected for proper connections and use. Please ensure my staff and I have access to all generators for inspection purposes.
- Any stage greater than 200 square feet or more than 30" above grade that is erected for performances shall be permitted and inspected prior to use, i.e. a separate permit would be required.
- Please ensure that all required permits have been issued at least 14 days prior to the event.

The intent of the International Fire Code is to provide a reasonable level of life safety and property protection from the hazards of fire, explosion or dangerous conditions. The requirements listed above offer a reasonable level of fire and life safety protection for this project. Any questions or concerns regarding fire service features or the comments listed above may be directed to the Kittitas County Fire Marshal's Office at (509) 962-7000.
