BACKGROUND:

On June 23, 1981, Kittitas County entered into a Lease Agreement with Stephen P. Brazitis for a hay shed which mistakenly encroached five feet upon the County's right of way on Vantage Highway when built. This Amendment to Lease establishes a new lease term with the Lessee for another 20 year term and puts a verbal agreement between previous Public Works Director, Paul Bennett and Lessee,

Stephen P. Brazitis into Lease form.

THIS AMENDMENT TO LEASE is made and dated this day of _______, 2016, by and between Kittitas County, a municipal corporation in the State of Washington, hereinafter referred to as the LESSOR, and Stephen P. Brazitis, and hereinafter referred to as the LESSEE.

WITNESSETH:

WHEREAS, LESSOR and LESSEE entered into a Lease on June 23, 1981, a copy of which is attached hereto and by this reference incorporated herein; and

WHEREAS, said lease expired on June 30, 2001 and at that time a verbal agreement was made and Lessee has continued to make lease payment at a rate of \$15.00 per year.

WHEREAS, it has been agreed between LESSOR and LESSEE that the lease term will be for 20 years, expiring on October 31, 2021 and at such time the lease can be amended and/or the building removed from said property.

NOW, THEREFORE, IT IS HEREBY AGREED by and between the parties to a change in rental rates and contract terms as follows:

1) Lease Rates for 07/01/01 thru 10/31/21 Term for the legal description attached as Exhibit "A" is as follows:

The Lessee shall pay as rental the sum of \$15.00 per annum, to be paid in advance on July 1st of each year during the term.

All other terms and conditions of the aforementioned lease shall remain the same.

WITNESSETH:

 The Lessor herewith grants to the Lessee a lease to the following described property:

The South Five feet of the right of way of the Vantage Road, in the East 1/2 of the East 1/2 of Lot 4, Section 4, Township 17 North, Range 19 East, W.M., Kittitas County, Washington,

for a period of twenty (20) years, commencing July 1, 1981, and expiring on June 30, 2001.

The Lessee shall pay as rental the sum of \$10.00 per annum, to be paid in advance on July 1st of each year during the term.

The Lessee shall be permitted to use the property only for the purpose of maintaining the present structure, being a hay shed, which is located thereon. The Lessee shall not be permitted in any way to improve the present structure, and in the event the structure is destroyed by fire or otherwise, the Lessee shall not be permitted to reconstruct the structure on the leased premises.

The Lessee herein has a grazing permit from the Lessor covering that portion of the Vantage Road which is excess to

the Road and lying in the East 1/2 of the East 1/2 of Lot

4. The Lessee herein owns property south of said description,
and has mistakenly encroached five feet upon the County's right
of way on the Vantage Road. It is agreed between the parties
that the Vantage Road right of way extends 75 feet from
the center line to the South boundary of the right of way.

It is agreed that this lease may be terminated by the Lessor, upon thirty (30) days written notice to the Lessee, when it is determined by the Lessor that the right of way herein above described is required for road purposes.

At the end of the term, if this lease is not renewed, the hay shed shall be removed if so requested by the Lessor.

It is agreed between the Lessor and the Lessee that if the Lessee shall at any time be in default in the payment of rent herein reserved, or in the performance of any of the covenants, terms, or conditions of this lease, and the Lessee shall fail to remedy such default within Thirty (30) days after written notice thereof from the Lessor to the Lessee at this address written below, the Lessor may, at its option, re-enter the premises and remove the Lessee therefrom.
