**TO PROVIDE FUNDING FOR CITY OF KITTITAS

WHEREAS: Funding has been secured in the amount of \$18,000.00 from CERB for the construction of a new picnic shelter;


WHEREAS: The City of Kittitas has asked Kittitas County to pledge \$12,000.00 to assist with purchasing the new playground equipment;

BE IT THEREFORE RESOLVED:

Kittitas County will dedicate -\$12,000.00 out of Capital Facilities Fund Real Estate Excise Tax to the City of Kittitas on a reimbursable basis for the budget year 2013 to purchase new ADA compliant playground equipment.


