RESOLUTION NO. 2012-008

RESOLUTION SPECIFYING FUNDING FOR THE MEMORANDUM OF  
UNDERSTANDING (MOU) BETWEEN KITTITAS COUNTY SUPERIOR  
COURT AND ALCOHOL DRUG DEPENDENCY SERVICE (ADDS)

WHEREAS, the Kittitas County Superior Court has established a drug  
court; and

WHEREAS, the Kittitas County Superior Court entered into an MOU with  
ADDS prior to the adoption of Resolution 2009-02; and

WHEREAS, the Board of Kittitas County Commissioners funded the  
Superior Court MOU for the 2009 calendar year, through Resolution 2009-23;  
and

WHEREAS, the Board of Kittitas County Commissioners finds that the  
Kittitas County Superior Court Drug Court provides a valuable service to the  
community; and

WHEREAS, Resolution 2005-108 established fund 115 Trial Court  
Improvement Fund; and

WHEREAS, the local judicial authority has stated its collective desire that  
a portion of the fund 115 be used to provide funding for the before mentioned  
MOU; and

WHEREAS, Resolution 2009-02 amended fund 131 Drug Enforcement  
Reserve Fund to allow the funds therein to be used for the expenses of the local  
drug court; NOW, THERFORE,

IT IS HEREBY RESOLVED that:

30 The Memorandum of Understanding between Kittitas County Superior  
31 Court and Alcohol Drug Dependency Service (ADDS) is hereby ratified and shall  
32 be funded for the 2012 calendar year as follows;

33 A. \$12,000 from the General Fund. These funds were previously  
34 authorized for the Drug Court specifically to pay for urinalysis.

35 B. \$10,000 from fund 131 Drug Enforcement Reserve Fund.

36 C. \$44,996 from fund 115 Trial Court Improvement Fund.

37 This ratification is limited to the MOU being conditioned upon future  
38 funding appropriations by the Board.
