

SPECIAL PROVISIONS

The following special provisions are to be used in conjunction with the latest edition of the "State of Washington Department of Transportation's Standard Specifications for Road and Bridge Construction", (unless otherwise specified), which by reference are hereby made a part of these documents.

The special provisions hereinafter contained shall supersede any conflicting provisions of the Standard Specifications.

Where the word **State** appears in the Standard Specifications, the **County of Kittitas** shall be used in this contract. Where the terms **Engineer** or **Secretary of Transportation** appears in the Standard Specifications, **Kittitas County Public Works Director** shall be used for this contract. Where the term **Washington State Highway** or **Transportation Commission** appears in the Standard Specifications, **Kittitas County Board of County Commissioners** shall be used for this contract.

DELIVERY OF BID PROPOSALS:

Sealed bids will be received at the following location:

Bids will be received until 2:00 p.m., December 5, 2013, and thereafter will be opened publicly and read aloud.

Each proposal shall be completely sealed in a separate envelope, addressed to Kittitas County Department of Public Works. The name of the project for the bid proposal must be plainly written on the outside of the envelope along with the date of the bid opening and the bidder's name. Kittitas County and the Kittitas County Public Works Department are not responsible for bids delivered late by the U.S. Postal Service. It is the responsibility of the Bidder to be sure the bids, if mailed, are sent sufficiently ahead of time to be received by the opening date and time.

RIGHT TO REJECT BIDS

The right is reserved to reject any and all proposals, to waive minor deviations from the specifications, to waive any informality in bids received, whenever it is in the County's best interest, and to accept the proposal deemed best for the County or to advertise for new proposals when in the opinion of the Kittitas County Board of Commissioners the best interest of the County will be promoted thereby.

LOCATION OF MATERIALS:

Materials to be stockpiled in Lower Kittitas County (Ellensburg vicinity) will be located within 15 miles of the Kittitas County Maintenance Shop, located at 14th & Okanogan, Ellensburg. Materials to be stockpiled in Upper Kittitas County (Easton vicinity) will be located within 15

miles of the Kittitas County Maintenance Shop, located at 1209 East Third, Cle Elum. In no event will the County haul more than a total of 15 miles to the material stockpile.

STOCKPILE OF MATERIALS:

All sealcoat chips shall be stockpiled and available for County use no later than June 1, 2014. All maintenance sand be stockpiled and available for County use no later than September 2, 2014.

CONDITIONS OF AWARD:

The Kittitas County Board of Commissioners reserves the right to purchase from suppliers other than the successful bidder, if for any reason the successful bidder is unable to promptly furnish maintenance rock of a quality which is satisfactory to Kittitas County's requirements.

COMPLIANCE WITH LAWS:

The successful bidder shall comply with all applicable federal, state and local laws, rules and regulations affecting its performance and hold the County harmless against any claims arising from the violation thereof.

CONTRACT DISPUTES:

Any contractual agreement shall be performed under the laws of the State of Washington. Any litigation to enforce such agreement or any of its provisions shall be brought in Kittitas County, Washington.

DEFAULT:

The Vendor agrees that if a lawsuit is instituted by the County for any default on the part of the Vendor, and the Vendor is adjudged to be in default, the Vendor shall pay to the County all costs and expenses incurred by the County in connection therewith, and reasonable attorney's fees. Venue shall be in the County of Kittitas, Washington.

INDEMNIFICATION:

To the maximum extent permitted by law, the Vendor shall be liable for and shall hold the County harmless from all damages and injuries caused to persons or property arising out of the performance of this Contract. The Vendor agrees to assume the defense of the County and its officers and employees in all legal proceedings or claims with third parties connected with the Vendor's performance under this Contract, to pay all expenses, including reasonable attorney's fees incurred directly or indirectly on account of such legal proceedings, and to satisfy any judgment rendered in connection therewith or to pay or reimburse the payment of any sums reasonable to settle such proceedings or claims.

PERSONAL LIABILITY:

It is agreed by and between the parties hereto that in no event shall any official, officer, employee or agent of the County be in any way liable or responsible for any covenant or agreement herein contained whether express or implied, nor for any statement or representation made herein or in any connection with this agreement.

ALTERNATE BIDS

Bid Sheet A - County to provide labor and equipment to load materials.

Bid Sheet B - Vendor to provide labor and equipment to load materials.

BID ITEM QUANTITIES:

The quantities of material listed on the attached bid sheets are for bidding purposes only. Kittitas County does not guarantee quantities shown will be purchased. It is offered to provide the Company with an estimate of demand. The Company shall make such revisions in their work as necessary to accommodate changes in the demand without additional compensation.

PAYMENT

Payment for materials delivered to Kittitas County each month will be made by County warrant on the following month.

The material in Bid Item No. 3 "Maintenance Sand" shall be produced from material which is free from roots, earth and other extraneous material. All oversized gravel occurring in the sources up to and including cobbles of 10 inches in the greatest dimension shall be entirely utilized in the production of maintenance sand.

Maintenance Sand produced from hard rock sources shall be produced in accordance with sections 3-01 and 3-02 or the Washington State Standards for Road, Bridge and Municipal Constructions, 2006 edition as amended, and shall meet the following grading requirements:

Passing 5/16 inch square 100% Passing U.S. No. 10 0-60%

Passing U.S. No. 200

0-5%

Sand Equivalent

40 minimum

In the final product, at least 50 percent by weight of the particles retained on the No. 10 and above sieves shall have at least one fractured face produced by mechanical crushing.

MEASUREMENT:

All material from stockpiles to the County must be weighed over certified scales. A copy of all scale tickets shall be attached to all invoices for payment.

No proposal bond or performance bond will be required.
