




DESCRIPTION/JUSTIFICATION OF AMENDMENT, MODIFICATION, OR CHANGE ORDER: <b>The contract provides financial assistance to the County solely for the expenses necessary to answer 911 calls originating in the county, which includes performing certain tasks and maintaining certain equipment necessary to operate Wireless Enhanced 911. Reimbursement shall be solely for eligible items included in Chapter 118-66 WAC. This amendment is intended to adjust the funding as outlined in the Statement of Work/Budget sheet.</b>			
11. AMENDMENT TERMS AND CONDITIONS: 1. The contract expiration date of June 30, 2006 remains <b>unchanged</b> . 2. <b>Change</b> the overall contract amount <b>from</b> \$82,389 <b>to</b> \$96,389; an increase of \$14,000. 3. In Exhibit B, Statement of Work and Budget, State Reimbursable column, make the following changes: Priority 2, B1 Call Receiver Salaries, <b>change from</b> \$27,175 <b>to</b> not to exceed \$45,175, an increase of \$18,000; B8 Mapping Display, <b>change from</b> \$4,000 <b>to</b> \$0, a decrease of \$4,000. <b>No other changes are required. All other terms and conditions of the original contract and any previous amendments thereto remain in full force and effect.</b>			
IN WITNESS WHEREOF, the Department and Contractor acknowledge and accept the terms of this contract amendment and attachments hereto and in witness whereof have executed this amendment as of the date and year written below. The rights and obligations of both parties to this contract are governed by this Contract Amendment Face Sheet and other documents incorporated herein by reference or attached and identified in the original contract document. 


