**APPEAL HEARING      FRUIT STAND - COMMERCIAL AGRICULTURE      COMMISSIONERS**

At 2:00 p.m. **CHAIRMAN CRANKOVICH** opened a hearing to consider an appeal filed by William Rowley of an administrative decision to permit a fruit stand within property zoned "Commercial Agriculture" within the Kittitas County Zoning Code.

He acknowledged with the current process it does not allow for public comment at the hearings, but his client would still like to be in attendance.
