PROCLAMATIONS

PROCLAMATION ROSLYN'S No. 1 MINE COMMISSIONERS

Commissioner Osiadacz moved to approve a Proclamation declaring May 10, 2017 as "Roslyn's No.1 Mine: Coal Miner's Remembrance Day" in Kittitas County and encouraged citizens to join them in celebrating and honoring the 125th Anniversary of the event as presented. Commissioner O'Brien seconded. Commissioner Osiadacz shared how proud she is of the pride that the Community has to this day and their support of their ancestors. She explained that it was a tragic day/event but out of it they worked hard to create a better life and to continue the culture, showing the true grit of the Community. She stated that she is very thankful to be a part of the Community and thanked everyone in attendance for showing up and showing their support. Commissioner O'Brien stated that it was a dramatic event that impacted the heart of our States western pioneer Community and it speaks to how resilient they are. He stated that the Board is honored to acknowledge this anniversary and thanked Commissioner Osiadacz for spear-heading and putting the Proclamation together. Chairman Jewell expressed how moved he was listening to the names be read from the Proclamation of the 125th Anniversary of event. He

felt it was remarkable and spoke volumes that 125 years later the individuals are still being remembered and the families who were so deeply affected and are being honored. He stated that this event had a large part of shaping the future of the Roslyn, and was honored to have the chance to recognize these families and their loved ones. Chairman Jewell invited anyone in attendance who would like to speak about the proclamation.

Jim Guerci, Chairman of the Roslyn, Ronald & Cle Elum Heritage Club (RRCH Club), stated that he was a descendent of a coal miner immigrant from Italy who worked in the mines for 30 years, and felt it was an understatement to say these folks were resilient. He talked about the hardships they survived and stated that this era was incredibly important and thanked the Commissioners for recognizing this 125th Anniversary.

Mike Miller stated that his Grandmother lost her father and brother in the explosion and shared mementos and pictures he had.

Sam Maybo, President of the RRCH Club shared that he had an Uncle that made it through the mines (50 years and ten months), without an injury but a black lung and then had to have it removed continued on. He thanked Commissioner Osiadacz for working to bring this Proclamation to light and felt it helps to promote the mission & vision statements of the RRCH Club.

Diana Burchak, said her Great Grandfather came with the survey crews in 1889 to Roslyn from Illinois. She shared her memories of listening to stories under the dining room table where conversations took place back then. She felt it was an amazing place to grow up and it provided a very stable up-bringing.

Fred Kruger, long time history teacher shared his memories of interviewing multi-cultural immigrants and miners etc., and how they worked long hours in the mines and the pay was low. He stated that when he visits the cemeteries he felt these folks were forgotten and is appreciative of the proclamation to bring recognition back to the miners and their families.

CITIZEN COMMENTS ON NON-AGENDA ITEMS

Douglas Fillbrook, Citizen expressed concerns relating to the Upper Dist. Court Judge, Kittitas County Sheriff's Office and the County Prosecutor.

Bill Hansen, Director of Economic Development - Kittitas County Chamber gave the Board a brief update on a few of the efforts the Chamber staff is doing around economic development in Kittitas County.

BOARD DISCUSSION/DECISION ITEMS

AGREEMENT MARION MEADOWS - DA-17-00001

Chairman Jewell opened a continued Public Hearing from April 18, 2017 to consider a Proposed Development Agreement for funding for processing the Planned Unit Development of Marion Meadows - DA-17-00001, noting the record is closed.

CDS

Vice-Chairman Laura Osiadacz announced she had disclosures to make and explained how she felt she should recuse herself from any decision/deliberation on the project. She stated that she had spoken with Deputy Prosecutor Neil Caulkins and shared with him her concerns for potential conflicts with the project such as her parents are the owners of the land next to the project (disclosed previously) and her husband currently works for the Company/Property owners that are funding the project. She stated that Mr. Caulkins agreed in the appearance of fairness it would be appropriate to recuse herself.

Commissioner Osiadacz left the room at 10:51 a.m.

Dan Carlson, CDS Director explained that the Public Hearing was previously heard on April 18, 2017 and continued to allow for discussion and decision to allow Staff to make revisions to Exhibit A of the Agreement to reflect the correct County hourly review rate and to be consistent with the reimbursable expenses in the County's Professional Services Agreement with Van Ness Feldman LLP. He stated that Staff has made the changes and they have been provided to the applicant, Van Ness Feldman LLP; Public Works and the County Budget and Finance Manager for review.

Jerry Martens, Agent for the Applicant indicated that he still has concerns. He questioned what constitutes billable hours? He stated that they are still working through some issues but wasn't opposed to moving forward. He indicated that he was assuming if there were issues down the road those could be brought back to the Board of County Commissioners.

Chairman Jewell explained that is not always the case and not a practice they want to get into especially if they are already aware of possible concerns/issues. He stated that the Board feels that practice is in the best interest of the County and the applicant.

Commissioner O'Brien moved to continue the Public Hearing to Tuesday May 16, 2017 at 10:00 a.m. under Board Discussion & Decision, noting the record is closed. Chairman Jewell seconded. Motion carried 2-0.
