Andrew Lyons, Board of Health Advisory Committee, stepped to the microphone and stated there were 10 nominations and reviewed. Mr. Lyons announced the Public Health Champion Award recipient, Kittitas County Health Network. Kittitas County Health Network was nominated for the work they have done in the community helping connect those in need to services in Kittitas County. The network was presented with an award and \$500.00. Robin Read introduced KCHN staff and other members of the team that started the A Team/Care Coordination team and thanked the committee for the nomination.

#### Administrative Officer Update

Chelsey Loeffers updated the following:

 Two COVID-19 Project Specialist positions have ended. Covid work has been fully incorporated in Communicable Disease division.

- Strategic Plan mid-cycle review update- this is a 5-year plan, and the department is doing a mid-cycle review/update to get department through the next 2 years.
- The department is currently doing a Community Health Assessment (CHA). This is a year-long process and being led by Lianne Bradshaw. The department will give an update on this process at the September BOH.
- The Foundational Public Health Services expansion adds an additional \$400,000.00 for the next budget year.
- Next month the department will update on the CHA from Lianne Bradshaw and an update on the COVID-19 Health Equity Coalition.

## Health Officer Update

Dr. Mark Larson gave a brief update on COVID-19 and noted that school guidance is out. The department will be working with schools to review this guidance.

Dr. Larson gave a presentation on Monkey Pox (MPV). The health department currently has some vaccine and medication for treatment distributed from the state. Dr. Larson discussed who would be currently eligible for vaccine based on exposure risks. Dr. Larson also reviewed the history and current numbers in the country and state. There will be future updates on Monkey Pox (MPV).
