# **Department Updates**

## Appoint Acting Health Officer via Resolution

Chelsey Loeffers stepped the podium and reviewed that the current resolution is out of date. This was last updated in 2005. The resolution would allow Grant County, Chelan Douglas County, and Okanogan County health officers to provide backup coverage when ours is out.

# Administrative Officer Update

Chelsey Loeffers updated the following:

- Updated the new department hours as of October 1, 2022, will be 8:00am- 4:00pm, Monday- Friday.
- No significant fee changes, so there is no update at today's meeting on fees.
- Governor Inslee to end COVID-19 State of Emergency on October 31, 2022.
  - No impact to COVID -19 funding
  - o End of vaccine requirements in health care settings
  - o Mask mandate for health care settings will remain in place
  - State DOH is working on a matrix defining what changes and what does not
- Attended the BOH annual orientation in Spokane put on by WSALPHO.



- The health department will host a flu clinic on October 21, 2022, for pediatrics.
- Full budget review next month.

#### Health Officer Update

Mark Larson discussed the great work Kate Johnson, Whitney Wheelock, and the rest of the communicable disease team is currently doing. COVID-19 continues to spread and deaths from COVID are still happening, mostly in older adults. The bivalent vaccine is out. Pfizer is out for ages 12 and up and Moderna is out for ages 18 and up. The health department will start with nursing homes for vaccine distribution.

Monkey Pox Virus numbers are flattening out due to education, outreach, vaccination, and treatment. Dr.Larson also gave a brief update on the following:

- Possible increase in influenza activity this year.
- Polio outbreaks are occurring in New York.
- Noro-virus outbreak on the Pacific Crest Trail.
- Discussion about systems that are available to use to determine air quality during fire seasons and what one to use. He also discussed the air quality index numbers and when to reduce outside activities.
- The hospital has recently had to send a mental health patient to Mary Bridge Hospital in Tacoma because Children's Hospital was full.
- Discussed regional medical officer position.

Erin Moore updated the board on a couple of the environmental health fees:

- Removal of redesign submittal fees
- Addition of Homeowner design of Pressure and alternative (already have homeowner gravity)

# Community Health Assessment progress presentation

Lianne Bradshaw reviewed a presentation on the Community Heath Assessment process the department is currently working through. Ms. Bradshaw reviewed the following:

- What is the Community Health Assessment
  - Aims to describe the health of the community
  - Looks at health status, community health needs, resources, and epidemiologic and other studies of current local health problems
  - o Identifies populations and areas that have better or worse health outcomes
  - o Helps measure how well a public health system is functioning
  - o Informs community decision-making and prioritization of health outcomes
  - Part of an ongoing broader community health improvement process (CHIP)
- What is the Community Health Improvement Plan
  - Uses CHA data to identify priority issues, develop and implement strategies for action, and establish accountability to ensure measurable health improvement
  - Action plan to address health issue identified in the CHA
  - Requires collaboration with multiples organizations/stakeholders
- Who are the community partners
- The Mobilizing for Action through Planning and Partnerships (MAPP) Framework
- The four assessments
  - Community Health Status Assessment
  - Community Themes and Strengths Assessment

- o Forces of Change
- Local Public Health System Assessment
- · Current work the department is doing

## COVID-19 Health Equity Coalition presentation

Mackenzie Carter presented the Mini Grant Project COVID-19 Heath Equity Coalition process. Ms. Carter reviewed the Social Determinants of Health and what contributes to these. Ms. Carter reviewed the project process that started in October of 2021 and ended with the applications submitted and chosen by June 2022. There were a total of twenty one applications received and six were rejected as they were deemed unallowable due to the meeting grant requirements. This made fifteen applications scorable. The Health Equity Coalition scored the applications. They were ranked and weighted, followed by group discussion. The following applicants were awarded:

- APOYO-\$22,500.00
- Gallery One \$25,000.00
- Kittitas County Early Learning Coalition \$18,915.00
- Thorp School District \$12,500.00
- Ellensburg School District \$21,085.00

## **Board of Health Member Updates**

- Dede Utley noted the following:
  - o KVH continues to have staff shortages and the toll it is taking on KVH.
  - KVH continuing to have struggles with transferring patients due to other facilities having staff shortages and lack of beds available.
  - Transportation to other facilities with road construction takes EMS out of service for great lengths of time.
  - Attended a round table discussion at Central Washington University about suicide in rural communities.
- Cory Wright discussed the following:
  - Kit-Com (911) organization is struggling with revenue issues.
  - The county will be working with the city and community partners to work on planning for continued growth in Kittitas County.
  - BOCC will be pursuing a BOCC Executive Advisory Committee to review how the County Commissioners handle workloads. The board will be appointing the members next week and will be facilitated by the Washington Association of Counties. The committee will be made up of:
    - Commissioner
    - 2 elected
    - 2 Department heads
    - Finance
    - 3 Citizens
- John Asriel updated the members on the Croton plant and uses.
