## Department Updates

# Administrative Officer/Director Update

Ms. Loeffers introduced Marie Marchand to the board. Marie Marchand briefly introduced herself as the new Mental Health Programs Coordinator. She has spent most of her career in non-profit and higher education work. She is a mental health advocate and is involved with NAMI (National Alliance of Mental Illness). Ms. Marchand is looking forward to working with community partners and staff to help reduce the stigma around mental health.

Audi Martinez introduced Maggie Amoth as the new Health Promotion Project Specialist. Ms. Amoth has a degree in Public Relations and a minor in Non-Profit Management. She looks forward to working in public health.

## Health Officer Update

Mark Larson M.D. presented information on suicide prevention. Dr. Larson presented that the suicide age ranges have changed from 2020. Information being gathered is showing that the pandemic has taken a harsh toll on U.S. teens mental health and reports increased feelings of persistent sadness or hopelessness. Data is showing that girls are presenting with higher percentages of symptoms than boys. Dr. Larson noted that with the data showing an upward trend that there is still hope and that resources and help are becoming more available. There was discussion about mental health and current issues that are fueling the mental health crisis.

## 2022 Year End Finance report

Katie Odiaga presented the 2022 year end financial report. She briefly discussed:



- 2022 Expenses
- 2022 Revenue
- Kittitas County Budget vs. Actuals for 2022
- Admissions Tax

Ms. Loeffers noted that the health department does have to receive funding from the county for local control to remain at the county level. If there was no funding from the county the state would assume control over the local health department.

## NEXUS Program Wrap Up Presentation

Lauren Wickerath and Anthony Morgan presented the NEXUS project overview. The project was a collaboration with University of Washington, Center for Disease Control, NASEN, and NYU. Health surveys were presented to clients, rapid testing for HIV antibodies and HCV antibodies, and incentives were given out. The original goal was to survey 150 participants, but reduced it to 100 to make the goal more achievable. 96 participants registered, 86 of those participants were eligible, and 85 surveys were completed. Testing results found 2 new reactive clients for HIV, 15 clients reactive for Hepatitis C, HCV Antibody, and 9 clients detected RNA for Hepatitis C HCV RNA. All of those clients were referred for confirmatory testing and treatment with a provider. Overall findings that almost half of those surveyed reported having adverse childhood events and trauma, often using drugs alone, and using mixture of drugs with fentanyl. Project NEXUS allowed the Exchange to expand hours for the community that allowed for an increase in traffic and increased education for community members.

There were 6 US Syringe Services Programs chosen to participate in the survey among underrepresented people who use drugs in Washington, Montana, California, Wisconsin, Connecticut, and North Carolina for a total of 1,576 surveys. The survey showed there was more methamphetamine use among Western sites. Opioid overdose was more common than stimulant overdoses and most people who used drugs had acquired naloxone, but there is still an unmet need.

## Board of Health Annual Orientation part two

Chelsey Loeffers presented the Local Board of Health Orientation Part Two. This presentation focused on the Role of the Board of Health and information on the following:

- Where do Local Health Jurisdiction's come from
- The six functions of public health governance
- Powers and duties RCW 70.05
- Board of Health Membership RCW 70.05.030- three county commissioners and three community member positions
- Director/Administrative Officer duties
- Health Officer duties RCW 70.05.050 and RCW 70.05.070
- WSALPHO Local Board of Health Training dates for 2023
- National Association of Local Boards of Health dates for 2023

#### Strategic Plan Presentation

Erin Moore gave a brief overview of where the health department is in its process for the midcycle review of the 2020-2024 Strategic Plan.

After the group brainstormed and prioritized work within the department it was narrowed down to:

- Customer Service: Customer feedback, Customer service Survey, Stakeholder meetings, Partner agencies
- Standardization: Onboarding/Cross training, Communications, Policies/procedures, Fee-based activities, Performance Evaluation
- Needs: Workforce development, FPHS Funding, Mental Health

Mrs. Moore discussed the outline and workplans. She also noted that the goal is to have accountability and develop a useful strategic plan.

## Social Determinants of Health Presentation

Cambron Walker presented on Social Drivers of Health. Mrs. Walker noted that Education Access and Quality, Health Care and Quality, Neighborhood and Built Environment, Social and Community Context, and Economic Stability all play a role in social drivers of health. Mrs. Walker also reviewed factors that goes into the drivers of health and approximately the percentage of effects they play on an individual. She also presented information on how health

drivers impact health inequities. There is also connections between health drivers/factors and Adverse Childhood Experiences (ACES). Having just one ACE can increase your risk of having an autoimmune disease, cardiovascular disease, diabetes, depression, or substance abuse. Mrs. Walker discussed potential areas to improve social drivers of health such as increase high school graduation rates, decrease school bullying, increase insurance coverage, adding sidewalks, increase homes with an entrance without steps, reduce anxiety and depression, positive relationships at home, work and community, employment programs, and high-quality childcare are just a few examples.
