#### **Department Business**

### Resolution to close to the public for all staff training 6/7/24

Chelsey Loeffers requested that the resolution to close to the public for all staff training be removed from the agenda. Staff plan to move this training day to fall 2024.

### Approve title change from Supervisor to Manager

Chelsey presented that she has been working with HR on changing titles of KCPHD supervisors from supervisor to manager to reflect the level of leadership/workload associated with these positions. The title changes do not have any budget impact. The BOCC approved the title change and directed staff to prepare documents to support the change.

## Approve temporary Homelessness and Affordable Housing Committee (HAHC) proposal scoring matrix and supporting documents

Chelsey presented the amended scoring matrix for the affordable housing committee to use to score the Oddfellows application. She presented the temporary scoring matrix and explained the process the department went through to develop the matrix. She also reviewed the proposed timeline associated with this work.
