RESOLUTION 2024-178 CAUSE NO. 24-2-00156-19 PROSECUTOR

Vice-Chairman Osiadacz moved to approve Resolution No. 2024-178, a Resolution Approving Kittitas County Code Chapter 2.73 Requests for Legal Defense in Yakima County Superior Court Cause No.24-2-00156-19. Commissioner Wright seconded. Motion carried 3-0.

UPDATE WSDOT I-90 COMMISSIONERS

Director Fredrickson gave an update to the Board on the traffic impacts due to the Vantage Bridge construction project. He discussed with the Board options being considered to mitigate the increase in

traffic some of which involve closures and signage. He stated WSDOT has some trial options they are considering implementing. Chief Deputy Kokjer stated the options presented he is not in favor of and has been attending meetings with Director Fredrickson. He stated that the Upper County traffic issues have to be addressed, and we can't address Lower County issues when the Upper County traffic impacts have been ignored for years. Director Fredrickson suggested that we offer WSDOT to address both Upper County and Lower County at the same time. Commissioner Wright stated he would like to see the relationship repaired between the County and WSDOT. The Board agreed they would only support both Upper County and Lower County traffic impacts be fixed by WSDOT at the same time, or they can close their ramps and manage them on their own. The Board asked that Public Works and the Sheriff continue to meet and work through options while keeping the Board in the loop.
