HR Director Killgore presented the 2025 – 2027 Appraisers union contract. Commissioner Osiadacz moved to approve the 2025 – 2027 Appraisers collective bargaining agreement. Commissioner Wright seconded the motion. Motion was approved; 3:0.

REQUEST TO APPROVE COLLECTIVE BARGAINING AGREEMENT BETWEEN KITTITAS COUNTY AND LOCAL 792CH (COURTHOUSE)

HR Director Killgore presented the 2025 – 2027 Courthouse union contract. Commissioner Osiadacz moved to approve the 2025 – 2027 Courthouse collective bargaining agreement. Commissioner Wright seconded the motion. Motion was approved; 3:0.

Commissioner Osiadacz moved to approve Resolution 2024-217 to adopt 2025 wage increases for regular non-union County employees. Commissioner Wright seconded the motion. Motion was approved; 3:0.
