1. Call to Order: 1:31 PM

2. Citizen Comments - none

3. Approval of Contract Extension with Tara Dunford, CPA

Mr. Carlson would like approval to extend the contract for 2025 to Tara Dunford, CPA.

Commissioner Osiadacz makes a motion to approve the 2025 contract for Tara Dunford, CPA and Commissioner Wright seconded the motion and the motion passes.

4. Cle Elum Skate Park

The City of Cle Elum has inquired about additional funding for the Skate Park too meet shortfalls resulting from prevailing wage impacts that were not contemplated in the original request. 5. Upper County Helipad

6. Upper County Recreation Center

Claire Nicholls from the Upper Kittitas County Recreation Center discusses possible need for funding the Upper County Recreation Center. She is waiting for more information before she knows an exact cost. Commissioner Wright would like more information and more discussion before deciding. Commissioner Osiadacz agrees to more information.

7. Treasurer Discussion Item-Cost Recovery Bill for 2025

Amy Cziske the Treasurer discussed The Cost Recovery Bill. If fees are collected, she would like the service fees to go to the General fund to possible pay for another staff position which is estimated to be \$128K. No decision was made.

8. Consideration of 2025 Appropriation for Morgue Feasibility Study

Cori McKean from the Coroner's office discusses the need for a feasibility study for a new Morgue for Kittitas County. The cost of the study is \$45K. The money will come from unused funds from 2024. All 3 Commissioners agree to the Feasibility Study.

9. YTD November Financial Update

Mr. Carlson discusses the end of the year financial update. General Fund Surplus is anticipated to be approximately \$3MM - \$4MM. The Budgeted deficit is approximately \$6.6MM

10. 2025 Budget-Recap and next steps

Mr. Carlson discusses priorities for 2025. Commissioners give feedback on this year's budget meetings. The consensuses were Communication between department heads and elected officials.
