#### CRITICAL AREAS UPDATE

Chad Bala briefed the Board of County Commissioners on the status of Resolution 2024-093. CDS will work with Facet NW Consultants to gather necessary data for a cost of \$13.9K.

#### SENATE BILL 5290


Jeremy Johnston briefed the Board of County Commissioners on Senate Bill 5290 that will go into effect January 1, 2025. This bill primarily focuses on changes to the development review timelines. Chad Bala and Jeremy Johnston will be reviewing the mandate and how it will affect current application fees.

## PUBLIC WORKS

#### G4-29290 Water Right Permit Assignment

Arden Thomas requested direction from Board of County Commissioners on the proposed partnership between Kittitas County and Joyce Palelek, a Vantage Area water right holder, and the subsequent request for Technical Assistance on Assignment of Application G4-29290 to the Department of Ecology. The proposed partnership between Kittitas County and Ms. Palelek would enable the groundwater permit application to be processed and would maintain and provide water mitigation options with Vantage. Kittitas County would enter into a mitigation agreement with Ecology for an annual fee that would initially be absorbed in the 403 Fund. Water user fees would be developed to cover these costs. The Board provided direction to staff to send the technical assistance letter upon addressing Commissioner Cory Wright's direction to verify the use of the term, "Town", with Chad Bala, Community Development Services Director.

#### Broadband Planning Update



12/23/24 MINUTES

Josh Fredrickson briefed the Board of County Commissioners about the status of the Broadband expansion. Two of the three projects received grants and are underway. The third project is seeking funding through the NTIA BEAD project for seven identified project areas. The application process is robust and each of the seven projects requires a separate application, due at the end of January 2025. Marc Eyler is assisting in the identification of non-serviceable areas and Josh requested Marc receive a stipend for his work. County Commissioner concurred and suggested a contract amendment to cover this cost.
