Chelsey Loeffers stepped to the microphone and noted that Kittitas County Code Chapter 13.08.080 establishes criteria for evaluating groundwater levels when determining septic system suitability for new subdivisions. The existing code is based on legacy technology and the new code accounts for modern alternative septic systems that are now permitted by the state. Recent developments in treatment technologies have expanded viable options for wastewater management while maintaining public health safety.


