ORDINANCE

NO. 98 - 16

REMOVING AND REPLACING SECTION 12.20.030(d) OF THE KITTITAS COUNTY CODE

WHEREAS: The Public Works Department has updated the list of primitive roads in Kittitas County that qualify under RCW 36.75.300 and have recommended changes to the existing list of primitive roads listed in Kittitas County Code 12.20.030(d); and

WHEREAS: The Board of Kittitas County Commissioners did hold a public hearing on Tuesday, July 21, 1998, at 10:00 a.m. to hear public testimony regarding the removing of 12.20.030(d) of the Kittitas County Code.

NOW, THEREFORE BE IT ORDAINED That the Board of County Commissioners after due deliberation and in the best interest of the public, does hereby recommend updating the list of primitive roads in 12.20.030(d) of the Kittitas County Code by replacing it with the below list.

BE IT FURTHER ORDAINED That the Kittitas County Code Section 12.20.030(d) be removed and replaced as follows:
