ORDINANCE

NO. 99 - 02

AMENDING KITTITAS COUNTY CODE

WHEREAS: RCW 47.36.110 authorizes yield signs and stop signs to be erected to provide safety at intersections. The Department of Public Works has reviewed the following and has determined that a yield sign would improve safety at the below named intersection; and

Yield sign on Boylston Road at the intersection with Stevens Road.

Yield sign on Silica Road at the intersection with Upper Badger Pocket Road

Yield sign on Park Creek Road at the intersection with Christensen Road

WHEREAS: A no parking zone was previously designated for a residence on Wilson Creek Road that formerly operated a beauty salon in the home. The business no longer exists and the Public Works Department has determined that there is not a need to restrict parking in this area; and

WHEREAS: Kittitas County Code Chapter 12.20.030(d) "Primitive Road System" should be amended by removing Perry Road from the list and changing it to a Rural Local Access (Class 09). Perry Road was been recently resurfaced which makes it no longer eligible for a primitive road classification.

WHEREAS: The Board of Kittitas County Commissioners did hold a public hearing on Tuesday, January 12, 1999, at 10:00 a.m. to hear public testimony regarding amending Kittitas County Code.

NOW, THEREFORE BE IT ORDAINED That the Board of County Commissioners after due deliberation and in the best interest of the public, does amend the Kittitas County Code as follows:

1. That the Kittitas County Code Section 10.12.010(2) be amended to add the following roads as "Yield Intersections" :

Yield sign on Boylston Road at the intersection with Stevens Road.

Yield sign on Silica Road at the intersection with Upper Badger Pocket Road

Yield sign on Park Creek Road at the intersection with Christensen Road

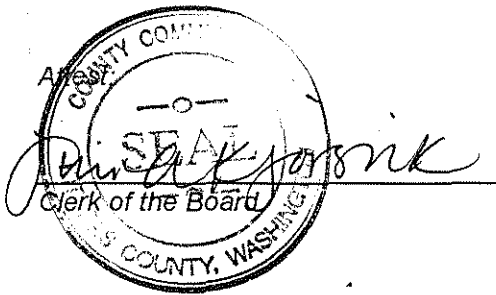
2. That the Kittitas County Code Chapter 10.07.010 "Areas Designated" be amended by removing "Wilson Creek Road from Burroughs Road (n/k/a Lyons Road) southerly 150 feet, east side".

3. That the Kittitas County Code Chapter 12.20.030(d) "Primitive Road System" be amended by removing Perry Road from the list and changing it to a Rural Local Access (Class 09).

BE IT FURTHER ORDAINED That this ordinance will become effective upon the installation of the appropriate signs.
