RESOLUTION NO 2006-92

AMENDING THE VETERANS ASSISTANCE MANUAL FOR KITTITAS COUNTY

WHEREAS: The legislature has provided that each county is to establish a Veterans Advisory Board as set forth in RCW 73.08.035.

WHEREAS: RCW 73.08.035(1) provides that each Veterans Advisory Board shall advise the county legislative authority on the needs of local indigent veterans, the resources available to the local indigent veterans, and programs that could benefit the needs of local indigent veterans and their families.

WHEREAS: RCW 73.08.010(1) provides that the county legislative authority shall consult with and solicit recommendations from the veterans' advisory board established under RCW 73.08.035 to determine the appropriate services needed for local indigent veterans.

WHEREAS: The Veterans Advisory Board for Kittitas County was established pursuant to the provision of RCW 73.08 on February 7, 2006.

WHEREAS: The Veterans Advisory Board for Kittitas County held numerous meetings over the course of the months since their creation and have submitted their advice and recommendations to the Kittitas County Board of County Commissioners.

WHEREAS: The Kittitas County Board of County Commissioners conducted a public hearing related to the recommendations of the Advisory Board and possible amendments to the Kittitas County Veterans Financial Assistance manual.

WHEREAS: The Kittitas County Board of County Commissioners finds it to be in the best interest of the general public and the veterans in Kittitas County to amend the Kittitas County Veterans Assistance Manual based upon the recommendations of the Veterans Advisory Board and the testimony and discussions presented during the course of the public hearings.

NOW, THEREFORE, BE IT RESOLVED that the Kittitas County Board of County Commissioners rescinds Resolutions 98-152 and Resolution 2001-109 as they relate to the adoption of the Kittitas County Veterans Assistance Manual.

BE IT FURTHER RESOLVED That the Kittitas County Board of County Commissioners hereby adopts the attached Kittitas County Indigent Veterans' Financial Assistance Manual as the manual for administration of the Kittitas County veterans' assistance programs for indigent veterans and families pursuant to RCW 73.08.010.

BE IT FURTHER RESOLVED That this resolution shall take effect on July 1, 2006.
