SEPA DETERMINATION OF NONSIGNIFICANCE

File: Flying A Land Rezone (RZ-24-00003 / CP-24-00003)

Description: Flying A Land LLC is proposing to rezone their 47 parcels, equaling 197.4 acres, currently zoned Agriculture 5 to Planned Unit Development. The rezone will allow the current use of the property to be consistent and compatible with the zoning code, as well as allow future expansion of existing uses. A comprehensive plan amendment (CP-24-00003), rezone application (RZ-24-00003), and SEPA checklist were submitted as part of the application packet. This project is being processed through the 2024 Annual Comprehensive Plan Docket process.
