1. **Briefly summarize the purpose of the project:** The project goals are to reduce sediment delivery to the Yakima River by increasing rooted bank vegetation and floodplain roughness; slow water temperature warming in the river by increasing shading over the side channel in the project area; and improve fish and wildlife habitat by reestablishing a riparian forest in the floodplain.

Project Goal

The goal of riparian restoration in the 595-acre Lower Kittitas Floodplain Restoration Project is to provide for riparian floodplain conditions to moderate water temperatures, decrease flood event severity, improve water quality, collect debris, and provide diverse side channels that are productive habitat for juvenile salmonids. Proposed early action riparian restoration will remediate prior forest clearing, providing floodplain roughness and restoring shade to current and future side channels in the Lower Kittitas Floodplain Restoration area.

Overview

The early action riparian restoration project will replant riparian forest across 2 sites: Worksite 1: 5.4 acres of former cleared pasture along 1300 feet of Spring Creek; and Worksite 2: 1 acres of former cleared pasture along 0.5 river miles. Both worksites will be planted in fall 2026, prior to floodplain restoration actions in 2028. Both worksites include three years of maintenance to provide live plant density of 250-300 plants/acre by 2029.

Methods

Project implementation includes planting trees and shrubs, and maintenance activities of weed treatment and fencing to exclude herbivory during establishment.

Permitting

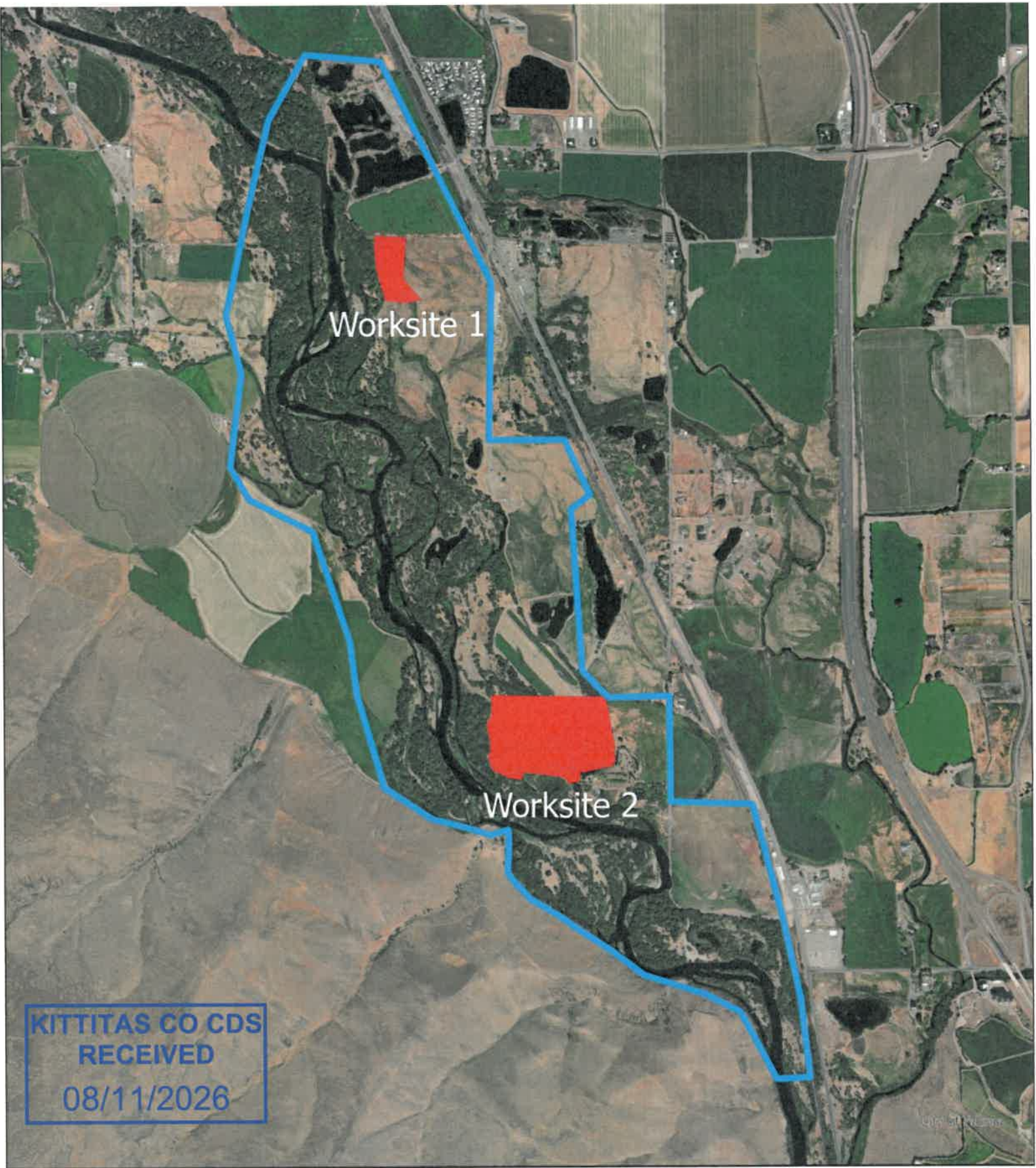
Cultural resources assessment and consultation has been completed for Worksite 1, and for the BLM parcel of Worksite 2. Assessment has been completed on the County-owned property for Worksite 2, and consultation is in progress; the state Recreation and Conservation Office is the lead agency on consultation. The BLM requires an archaeological monitor on their property during ground-disturbing implementation activities, which will include planting and fence installation.

Riparian Plant Installation

Mid-Columbia Fisheries Enhancement Group (MCF) will plant 3,720 native plants at Worksite 1 and 5,100 native plants at Worksite 2. Dense installation of these plants will increase shading, create habitat complexity and provide floodplain roughness, to create high quality fish and wildlife habitat. MCF has hired a contractor to install the plants in October 2026.

Stewardship/Maintenance of Riparian Plantings

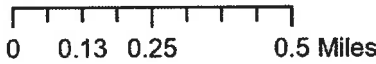
Riparian planting projects require substantial maintenance to ensure that plant establishment is successful. Three years of maintenance are planned for this project. To reduce plant mortality due to herbivory, a temporary ungulate deterrent fence will be installed surrounding the plants. MCF will control weeds in the planting area through 2029.

-  Project area



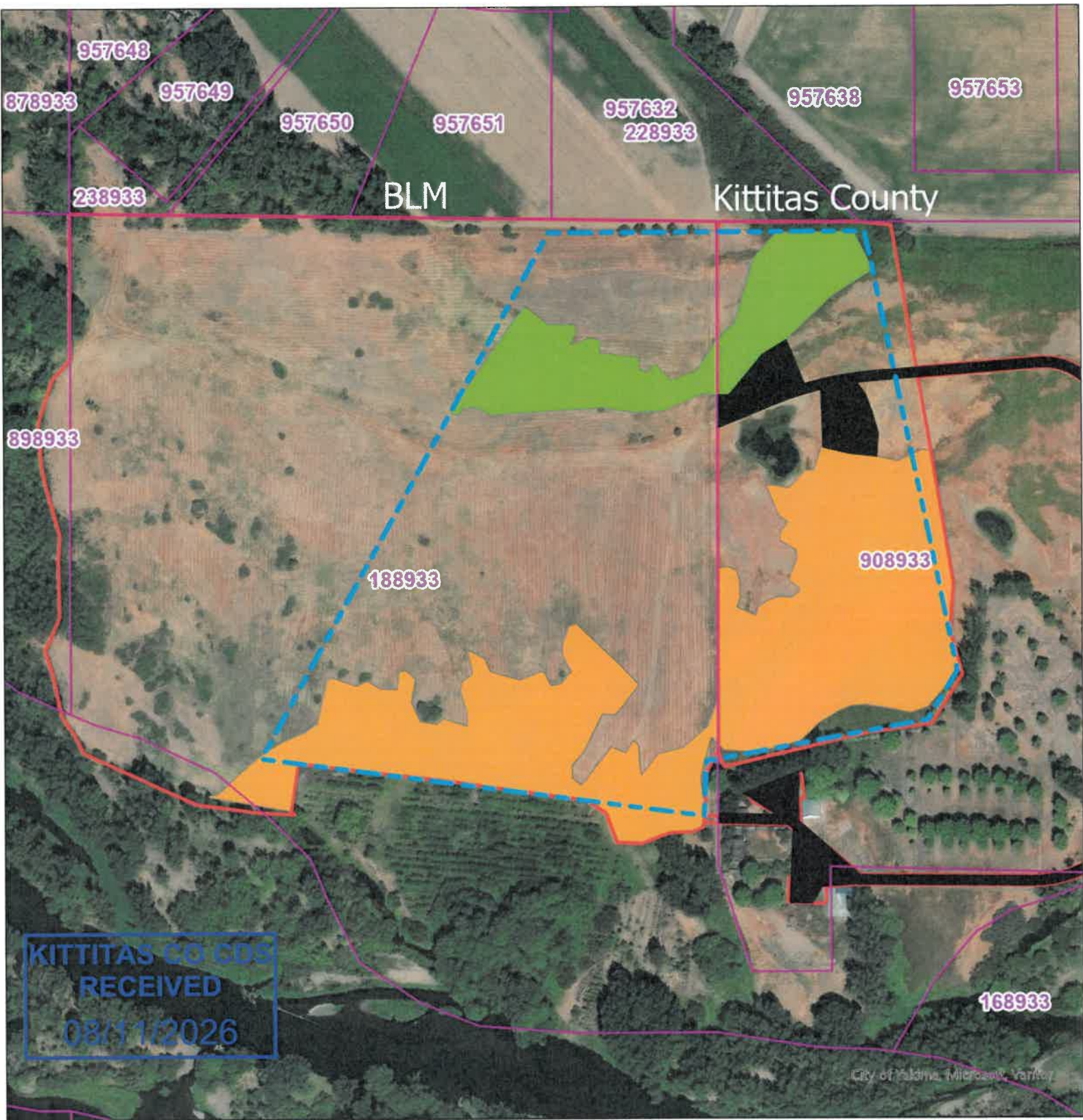
