The Snoqualmie Tribe [Tribe] is a federally recognized sovereign Indian Tribe. We were signatory to the Treaty of Point Elliott of 1855; we reserved certain rights and privileges and ceded certain lands to the United States. As a signatory to the Treaty of Point Elliot, the Tribe specifically reserved among other things, the right to fish at usual and accustomed areas and the “privilege of hunting and gathering roots and berries on open and unclaimed lands” off reservation throughout the modern-day state of Washington.

Thank you for the opportunity to review and comment. Based on the information provided and our understanding of the project and its APE we have no substantive comments to offer at this time. However, please be aware that if the scope of the project or the parameters for defining the APE change, we reserve the right to modify our current position.


I was able to apply a previous CRS to the project area (1697494), so attached please find a letter from DAHP concurring with the findings, results and recommendations from the Cultural Resources Survey (CRS) entitled “CRS for the Yakima Basin Integrated Plan Kachess Drought Relief Pumping Plant Transmission Line; Kittitas County WA,” (Camuso et al. 2020). As no cultural resources lie within the project area, no further direct archaeological supervision of the project is required; however, eligible site 45KT04383 lies immediately to the west of the Aol. In the event the project scope begins to drift toward the site, a barrier fence that is easily seen must be constructed to protect that site boundary. It is strongly advised that an Inadvertent Discovery Plan (IDP) is followed, with a copy kept onsite at all times, and having all crew members briefed on IDP procedures.

Please note this is only the opinion of DAHP and Affected Tribes may have access to proprietary information unavailable to DAHP at the time of this writing. Comments from Tribal Cultural Services departments or significant changes to project design may require review of this decision.



Hi Ellie,

We have completed our review of the SD-25-00001 Easton Research and Rearing Facility Outfall Application.

Please be advised that the proposed project lies within the traditional territory of the šnp'əšqwáw səxw (people in between) or Wenatchi, one of the twelve tribes that makes up the Confederated Tribes of the Colville Reservation (CTCR), which is governed by the Colville Business Council (CBC). The CBC has delegated to the Tribal Historic Preservation Officer (THPO) the responsibility of representing the CTCR with regard to cultural resources management issues throughout the traditional territories of all of the constituent tribes under Resolution 1996-29. This area includes parts of eastern Washington, northeastern Oregon, the Palus territory in Idaho, and south-central British Columbia (see attached map).

Based on State and Tribal sensitivity maps documenting the known occurrences of pre-contact, ethnographic, historic, and/or religious sites, **we find that the proposed undertaking has a very high risk of impacting both known and unknown cultural resources.**

The project application states that no work is proposed in or near historic or cultural sites, however, as shown by the provided site maps the project area is proposed within 500ft or less of several known archaeological sites, of which at least two have been determined to be eligible or potentially eligible for inclusion on the National Register of Historic Places (NRHP). In fact, the site boundaries of at least one NRHP eligible site appear to be partially within the APE of the project based on the provided site plans.

In one of the more recent cultural resource surveys conducted in 2019 within a portion of the proposed undertaking's APE (*Cultural Resources Investigation of the Yakima Basin Integrated Plan Kachess Drought Relief Pumping Plant Transmission Line*, prepared by the Yakama Nation Cultural Resource Program, NADB 1697494) field crew identified several new archaeological sites despite noting that portions of the surveyed area had dense vegetation which at times allowed for only 10% surface visibility. Washington State's Archaeological Risk Assessment Model also suggests that this entire area, including as of yet unsurveyed portions within the project's APE, is at very high risk for cultural resources to be

present. As well, according to the CTCR's internal archaeological registry, a Traditional Cultural Place (TCP) of the CTCR is also located immediately adjacent or just within the APE of the proposed undertaking.

Given the extent of the proposed ground disturbance, which includes the placement of a more than 4,000 square foot facility on a concrete slab at grade, a 2,800 square foot parking lot, and the placement of several new wells and water lines, the CTCR does not concur with the level of effort to identify this project's potential impacts to historic properties and requests more information about the proposed project, including, ideally, a GIS shapefile showing the undertaking's APE and location of proposed facilities for reference. We would also insist that the proponent develop and have on site an Inadvertent Discovery Plan for all project undertakings as well as hire a cultural resources monitor for all ground disturbing activities. Should any cultural material be identified over the course of this project, the CTCR would also request that we are informed and provided with copies of any subsequent reporting related to these discoveries.

I would also like to note that the CTCR has an administrative arm of tribal government dedicated to advising the CBC on matters of importance to the Colville Tribes throughout their traditional territories. These are the Traditional Territory Advisors. The Traditional Territory Advisors' responsibilities to CBC are broader including a suite of natural and cultural resources, socio-economic impacts, land development, air quality, pollution, commercial facilities, health care, solid waste, waste water, wildfire, agriculture, floods, legislation, etc. This administrative team consists of Mr. Sirois, Dr. Capuder, Mr. Sam, Ms. Sam, Mr. Davis, and Ms. Bent, all of whom are copied on this email. Please include this team on future standard notifications of undertakings, projects, areas of effect or impact.

Please note that the History/Archaeology Department will continue to be the sole recipient and contact for historic property review and compliance beyond initial contacts in all matters of historic property identification, evaluation, impact assessment treatment or mitigation and for all restricted and confidential historic property reports.

Thank you for submitting your project for compliance review with the Confederated Tribes of the Colville Reservation. Based on remote review of this parcel(s) it appears that some or all of the parcel(s) consist of forestland, and it will require a Forest Practices Application (FPA) from the DNR if merchantable timber is removed/harvested as part of the proposal and/or is being converted out of forest land (RCW 76.09 and WAC 222). The FPA would need to meet the requirements of the Forest Practices Act and its rules. It is our recommendation that the applicant meet with our local forest practices forester to discuss, they may call our Southeast Region office at (509) 925-8510 to schedule an appointment.

Based on a better understanding of this application's ideas, DOH provides this email to summarize status of possible water system or well uses.

In the vicinity of this applicant's property are two public drinking water systems, both having a single, approved well, and showing the following:

- Lake Easton State Park East (SP3801) – Active: 20, Approved: 34
- Lake Easton State Park West (SP013C) – Active: 58, Approved: 0

So, if the applicant wants to connect to one of these systems, please consider the following:

- To connect to the “East” park, this system has connection availability. For the “connection”, DOH requires submittal of the design of the interconnecting piping and an estimate of the water use by the applicant's facility.
- To connect to the “West” park, this system currently has no available connections, but that is because its “capacity” was never evaluated. To connect, DOH requires completion of a capacity analysis of the “West” park system, including estimated water usage by the applicant's facility, and if this capacity analysis shows sufficient capacity, then submit of the design of the interconnecting piping.

For any design submittals and for any capacity analysis calculations, DOH requires these to be prepared by a Professional Engineer licensed in the State of Washington.

Additionally, the applicant had considered another well with a well tag “AFT387” – this well is not an approved well, so the applicant would need to complete source approval and complete a new water system application (both required to be completed by a Professional Engineer licensed in the State of Washington); however, as noted in my original email below, the applicant needs to answer that set of questions so that we can determine if, as a standalone entity, it meets the definition of either a Group A or Group B water system.
