This review is in response to the proposed undertaking **AU-25-00008 Fredrickson**, for an Accessory Dwelling Unit at Edge Bluff Loop Road, Ellensburg, WA.

The proposed undertaking is outside of the Traditional Territories of the Colville Confederated Tribes, but the site does fall within an area of moderate risk for the potential presence of cultural resources according to the Washington State Department of Archaeology and Historic Preservation's statewide predictive model. Furthermore, the proposed undertaking involves ground disturbance over an area of 3,240 square feet which has not been surveyed within the past 10+ years and which occurs within 1 mile of known precontact archaeological resources.

For these reasons, we request a cultural resource survey prior to project implementation and that there be an IDP in place during all ground disturbing activities.


