**Location:** One tax parcel (#19279), located off Green Canyon Lane, a private road, approximately 3.13 miles Northwest of Ellensburg, WA. In a portion of the NW ¼ of the SE ¼ of Section 8, Township 18, Range 18; Kittitas County parcel map number 18-18-08040-0016.

**Proposal:** The applicants have proposed the addition of a 1,475 square foot accessory dwelling unit (ADU) with an attached garage to the existing property. The property has an existing Single-Family Residence with an attached garage, as well as a garage/shop. The subject property is zoned Agriculture-20. The subject property has a land use designation of Rural-Working.

All comments will be considered in the decision-making process, and any person has the right to comment on this application and receive notification of the Community Development Services administrative decision, once made. Appeals to an administrative land use decision may be filed within 10 working days with Kittitas County Community Development Services as outlined in Chapter 15A.07 of the Kittitas County Code. The current appeal fee is \$1670.
