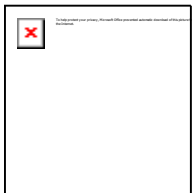
This review is in response to the Accessory Dwelling Unit application: AU-26-00003 Campbell. We've reviewed the proposal against State and Tribal sensitivity maps documenting the known occurrences of precontact, ethnographic, historic, and/or religious sites. Based on this review, we have no major concerns for the project's potential to impact cultural resources. While still within areas of usual and accustomed use, we will also note that this area falls outside of the area delineated by the Colville Business Council as the traditional territory of the tribes which compose the Confederated Tribes of the Colville Reservation. As such, we recognize that there may be other interested parties, particularly tribal partners, who have more immediate concerns for the potential effects of this undertaking to resources of historic, cultural, or religious significance. We will defer to their concerns and opinions with regards to this undertaking.
