Project Name (File Number): Mastec Communications (ACU-25-00001)

Applicant: Level 3 Communications (landowner), Jeff Lienert for Mastec Communications (authorized agent)

Location: One (1) parcel #14223, in a portion of the SW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 31, T. 20, R. 16, WM in Kittitas County, bearing Assessor's map number 20-16-31030-0021.

Proposal: The applicants are proposing to construct a new 23' by 36' communications equipment shelter on a new 36' by 46'9" concrete pad, defined as a Communication Facility. Communication facilities may be authorized in Agriculture-5 zoning designations with an administrative conditional use permit. The subject property is zoned Agriculture-5.

Written Comments on this proposal can be submitted to CDS any time prior to **5:00 p.m. on March 6, 2025.** This is an administrative conditional use permit request and does not involve a public hearing. Any person has the right to comment on this application and request a copy of the decision once made. Written comments submitted to the County regarding this application will be included in the public record in their entirety. All comments will be considered in the decision-making process, and any person has the right to comment on this application and receive notification of the Community Development Services administrative decision, once made. Appeals to an administrative land use decision may be filed within 10 working days with Kittitas County Community Development Services as outline in Chapter 15A.07 of the Kittitas County Code. The current appeal fee is \$1670. Appeal procedures can vary according to the type of decision being appealed, and are described in Kittitas County Code, Title 15A.

Environmental Review (SEPA): The County does not anticipate this project requiring SEPA review.
