

## LEGAL DESCRIPTION

That portion of the NEd of Section 18 and that Portion of the Wa Ned of Section 17 of Township 19 North, Range 16 East, W.M., Kittitas County, Washington which is bounded by a line described as follows: Beginning at the northeast section corner of said Section 18 at which point is the true point of beginning; thence S 87°17'11"W, along the north line of said section 18, 2612.80 feet to the north quarter section corner of said Section 18; thence S 3°26'65"E along the west line of said NED of said Section 18, 1200.39 feet; thence S 87°25'57"E, 2932.92 feet; thence N 44°04'33"E, 473.65 feet; thence N 40°40'38"E, 60.00 feet; thence N 49°19'22"W, 2°8.73 feet; thence along curve of radius 322.94 feet, to the right, an arc length of 470.62 feet: thence N 34°10'30"E, 370.00 feet; thence along a curve of radius 403.59 feet to the left, an arc lenth of 250.50 feet to the north line of said Section 17; thence S 87°23'49"W, 823.89 feet to the true point of beginning.
