- INSTRUMENT: USING A NIKON DTM 350 FIVE SECOND TOTAL STATION WITH RESULTING CLOSURES EXCEEDING THE MINIMUM ACCURACY STANDARDS AS SET FORTH BY WAC 332-130.
- 4. THE BOUNDARY LINES AND CORNERS DEPICTED ON THE MAP ARE PER RECORD TITLE INFORMATION AND REPRESENT DEED LINES ONLY. THEY DO NOT PURPORT TO TO SHOW OWNERSHIP LINES THAT MAY
- OTHERWISE BE DETERMINED BY A COURT OF LAW. 5. FIELD WORK FOR THIS PROJECT WAS PERFORMED DURING APRIL OF 2000 AND NOVEMBER OF 2012 AND THIS MAP IS THEREFORE A REFLECTION OF CONDITIONS AT THAT TIME.
- 6. IT IS NOT THE INTENTION OF THIS SURVEY TO PROVIDE A DEFINITIVE BOUNDARY FOR THE NORTHWEST AND SOUTH LINES OF PARCEL A WHICH IS LABELED AS "APPROXIMATE". THE PRIMARY CONCERN OF THIS PROJECT IS TO CORRECT THE COMMON LINE BETWEEN PARCELS A AND B PER NOTE 1. THE BALANCE OF PARCEL A IS ONLY SHOWN TO PROVIDE A GRAPHIC REPRESENTATION OF THIS PARCEL. ACREAGE
- IS ALSO SHOWN AS A PLUS OR MINUS VALUE.






