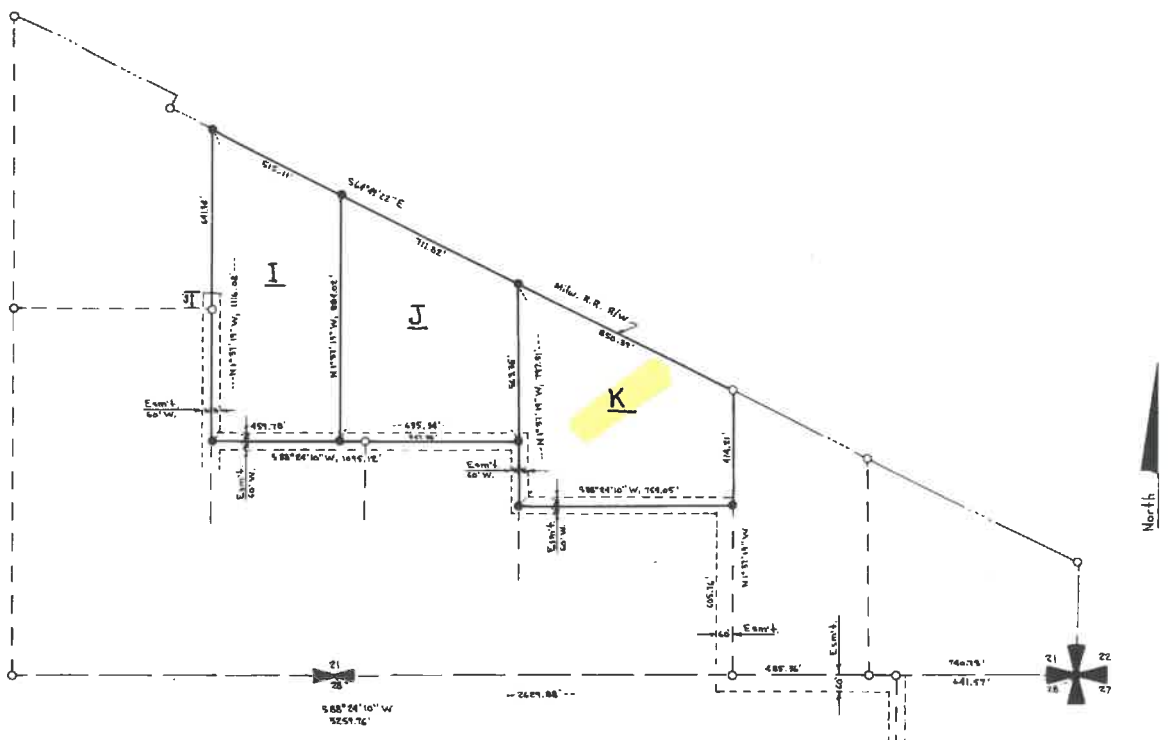


Sec. 21, T. 20 N., R. 14 E., W. M., Kittitas Co., Wa.

Description of Parcel I

The West 459.78 feet of the East 3,080.26 feet of the South Half of Section 21, Township 20 North, Range 14 East, W.M., Kittitas County, Washington lying southerly of the Chicago, Milwaukee, St. Paul and Pacific Railroad Company southerly Right of Way.
EXCEPT the South 839.71 feet thereof.
Subject to easements, rights of way, restrictions and reservations, if any, apparent or of record.
Contains 10.56 Acres, more or less.

Description of Parcel J

The West 635.34 feet of the East 2,620.48 feet of the South Half of Section 21, Township 20 North, Range 14 East, W.M., Kittitas County, Washington lying southerly of the Chicago, Milwaukee, St. Paul and Pacific Railroad Company southerly Right of Way.
EXCEPT the south 839.71 feet thereof.
Subject to easements, rights of way, restrictions and reservations, if any, apparent or of record.
Contains 10.56 Acres, more or less.

Description of Parcel K

The West 759.05 feet of the East 1,985.13 feet of the South Half of Section 21, Township 20 North, Range 14 East, W.M., Kittitas County, Washington lying southerly of the Chicago, Milwaukee, St. Paul and Pacific Railroad Company southerly Right of Way.
EXCEPT the South 605.76 feet thereof.
Subject to easements, rights of way, restrictions and reservations, if any, apparent or of record.
Contains 10.56 Acres, more or less.

Parcels I, J, and K are Subject to and have the Sixty Foot Easement as shown hereon for Ingress and Egress to the Nelson Siding County Road.
