THENCE SOUTH 00°10′20″ EAST ALONG SAID EAST BOUNDARY, 628.16 FEET TO THE BEGINNING OF A NON-TANGENT CURVE, CONCAVE TO THE SOUTHWEST, THE CENTER OF SAID CURVE BEARS SOUTH 89°49′40″ WEST, 50.00 FEET;

THENCE NORTHWESTERLY ALONG SAID CURVE, THROUGH A CENTRAL ANGLE OF 101°32′13″, AN ARC LENGTH OF 88.61 FEET;

THENCE CONTINUING NORTH 89°49'26" EAST ALONG SAID NORTH BOUNDARY, 228.23 FEET TO THE NORTHEAST CORNER OF SAID LOT 20;

THENCE SOUTH 00°10'20" EAST ALONG THE EAST BOUNDARY OF SAID LOT 20, 139.11 FEET TO THE BEGINNING OF A NON-TANGENT CURVE, CONCAVE TO THE SOUTHEAST, THE CENTER OF SAID CURVE BEARS SOUTH 11°42'33" EAST, 50.00 FEET;

THENCE SOUTHWESTERLY ALONG SAID CURVE, THROUGH A CENTRAL ANGLE OF 78°34'08", AN ARC LENGTH OF 68.56 FEET TO THE BEGINNING OF A REVERSE CURVE HAVING A RADIUS OF 30.00 FEET:

THENCE ALONG SAID CURVE, THROUGH A CENTRAL ANGLE OF 41°24'35", AN ARC LENGTH OF 21.68 FEET:

THENCE SOUTH 41°07′53" WEST ALONG THE SOUTHEASTERLY BOUNDARY OF SAID LOT 19, 272.49 FEET;

THENCE NORTH 00°17'56" WEST, 412.74 FEET TO THE TRUE POINT OF BEGINNING.
