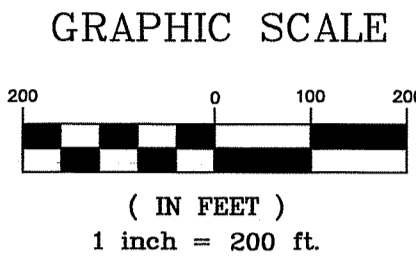
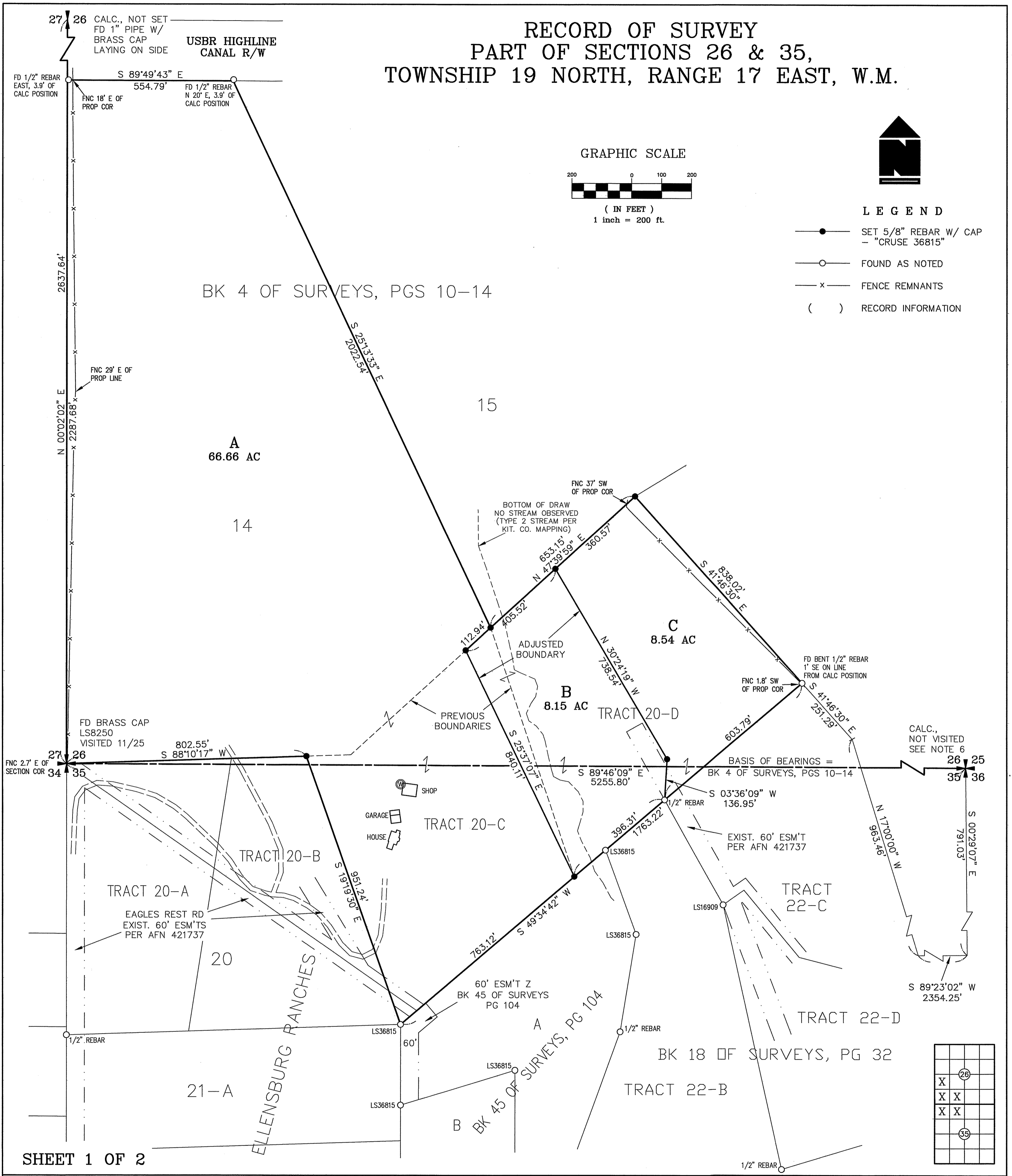

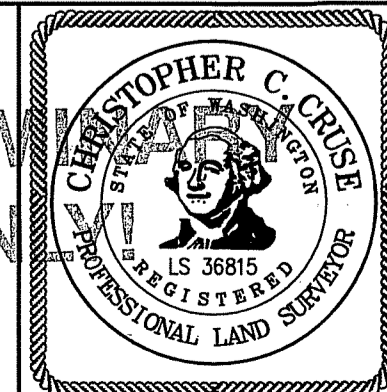

5. ALL CORNERS SHOWN AS FOUND ARE WITHIN 1.0' OF CALCULATED POSITION UNLESS NOTED OTHERWISE. MOST CORNERS FOUND APPEAR TO HAVE BEEN SET IN 1977 FOR BK 4 OF SURVEYS, PGS 10-14, AND ARE LEANING OR UNSTABLE.
6. I HELD THE SW CORNER OF SECTION 26 AND MONUMENTS FOUND FROM BK 45 OF SURVEYS, PAGE 104 AS THE BASIS OF CONTROL FOR THIS SURVEY. DUE TO THE DISTORTION BETWEEN THE FOUND MONUMENTS IN ELLENSBURG RANCHES THE POB FOR THESE PROPERTIES WAS HELD FROM ADJACENT MONUMENTS.

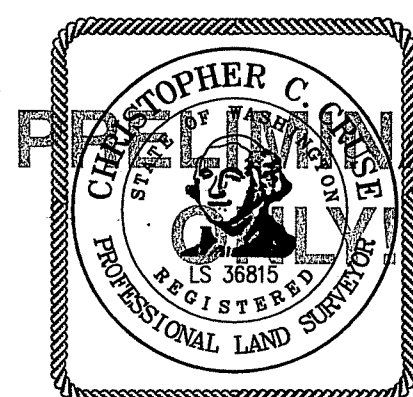
