Pursuant to RCW 36.70B.130 and KCC 15A.06, notice is hereby given that on December 2, 2014 the Kittitas County Board of County Commissioners approved the Anderson Hay Non-Project Rezone (RZ-14-00002 & CP-14-00001) through the 2014 Annual Comprehensive Plan Docket process.
