State Environmental Policy Act Determination of Non-Significance

Description: Kittitas County 15B allows for yearly amendments to development regulations through the

docketing process. Pursuant to 15B.04.030 Docketing for the calendar year shall be taken from January 1st to June 30th of each calendar year. Amendments to development regulations docketed by June 30th shall be approved or denied by the board of county commissioners on or before December 31st of that same calendar year. On June 24, 2019 Jeff Slothower, agent for landowners Ronald and Bonnie Scott submitted a Comprehensive Plan Map amendment application, Rezone application, and associated SEPA checklist for the 2019 docket. The applicant proposes a rezone of parcel #061634 from Residential to General Commercial. Parcel #02903 is currently a split zone parcel with both General Commercial and Residential zoning. The proposal would eliminate the split zoning by converting the entire parcel to General Commercial. The parcels are located within the Easton Type 1 LAMIRD bordering I-90 split between Sections 11 and 12, T.20N, R.13E, W.M.; Kittitas County parcel map numbers 20-13-11051-1104 and 20-13-12030-0003.

Any person, affected tribe, or agency may submit comments to the lead agency within 15 days of the date of issuance of the DNS. The lead agency will then: retain, modify, or withdraw the decision.
