

March 31 deadline for comments on SR97 pond excavation project

KITTITAS COUNTY – Scott and Gayle McIntosh have asked the county for permission to team with MDJ Development on a project that would see three ponds on their property excavated.

Kittitas County Planner **Jeff Watson** said the cutoff for comments on the proposal is Tuesday, March 31, before 5 p.m.

As MDJ explains in documents filed with the county, "The landowners want to do this to help with their cattle operation. We'll wash or screen the material we excavate and then haul it offsite to one of many [housing] developments in progress.

"With growth in Kittitas County it is an ongoing challenge to keep up with the demand of construction materials."

By "building materials" MDJ is referring to the sand and gravel to be excavated from the three ponds.

The company is said to

have submitted a plan for cleanup and a low impact approach to the surrounding environment, including Dry Creek.

The address of the McIntosh property is 7820 SR97.

Wrote Watson in a recent memo, "This may be the only opportunity for the public to comment on the environmental impacts of the proposal.

"Mitigation measures may be required under applicable codes, such as Title 17 Zoning, Title 17A Critical Areas, and the Fire Code, and the project review process may incorporate or require mitigation measures regardless of whether an Environmental Impact Statement is prepared. A copy of the threshold determination may be obtained from the county."
