## Lindsay and Doc,

I hope all is well at the County offices. Ourselves, and a number of other anglers, have floated the Diversion Dam section of the river for many years. In order to portage around the diversion dam, we pull over on the immediate upstream side on the South side of the river just above the fish ladder, and carry our boats (single person pontoon craft or raft) up the short hill around the chain link fence at the ladder, through the blue swing gate (which is never locked), and drop it back in the water on the downstream side. I went to do that again this weekend, and found a freshly installed "No Trespassing" sign placed right in the uphill path 5' off the river. I had always thought a safe portage (ingress and egress) path had to be provided, and that it could never be restricted. Could you look in your records and share your interpretation?

Also, John Easterbrooks from WDFW sent a note mentioning the extensive response you've received in opposition to the access we'd been working on above the diversion dam on the North side of the river. I will rally some support on this end (both for written comments and testimony) and am trying to arrange my schedule so I can attend the meeting on the 11th. It looks like the same people who are responsible for the No Trespassing signs may be the ones who hired the attorney to compose that negative response.
