For Bright Side:

- The height of the casing above finished grade is acceptable based on the following: (a) the wellhead is, and will always be, inside a building, (b) all other items are addressed (need a vent, need all penetrations through the cap to be sealed, it appears the cracks in the floor have been sealed, and (c) if the water system ever has a reason for pulling the pump for maintenance or replacement, then the casing will be extended via welding on a piece. If, at this time, providing a vent and sealing the entries through the cap, as required for approval, results in the need to replace the well cap, then the casing should be extended at this time.
- Regarding other acceptability issues the depth, based on the existing well Well Log and the video information, is sufficient to eliminate the need for GWI evaluation. Now, we will need to see water quality to determine if it can be approved (i.e., if some contaminant is present, such as nitrate, then treatment would be required).
