As a reminder, we are proposing removal of the primitive camp site we have on our property and which is located within a boundary from the wetland (not actually within the wetland). We are proposing to remove the fire pit and rocks and replant the entire boundary area with native vegetation to a distance of not less than 50 feet. We would do so at any revegetation density requested by Ecology.
