Per RCC 15A.03.10 the following applies:</p> <ol style="list-style-type: none">1. The applicant shall post the subject property with signs as required by Community Development Services.2. Signs shall be posted on each road frontage on the subject property and shall be clearly visible and accessible.3. Signs shall be posted and on-site prior to the issuance of a Notice of Application.4. The sign shall be posted in a sturdy manner to remain on-site until 10 days after the expiration of the Notice of Decision appeal period. It shall be the responsibility of the applicant to properly dispose of the sign.5. At the time of development application, Community Development Services will identify the number of signs needed and the exact location of each sign on the subject property.6. It shall be the responsibility of the applicant to place the structure on which the sign will be posted on site. At such time the structure and sign is in place, the applicant shall contact Community Development Services.
