- 2. The number of RV spots and connections meets the definition of a Group A public water system as a Group A public water system, DOH ODW has authority.
- 3. The existing well has not been approved as a public water system source.
- 4. For the proposed use, DOH ODW requires submittal of a public water system application, to be prepared by a Professional Engineer licensed in the State of Washington. As the authority, this application is to be submitted to DOH ODW.
