VIRTUAL PUBLIC HEARING INSTRUCTIONS

In conformance with the Governor's Emergency Proclamation 20-28, and in order to prevent the spread of COVID-19, Kittitas County is not conducting in-person hearings at this time. Therefore, a virtual hearing will be held using Webex video conferencing web application, which includes a phone-in option.

Before You Begin a Virtual Public Hearing:

- Locate the Meeting Link, Meeting Number, or dial-in number on hearing notice.
- If you have exhibits to be entered into the record, they must be emailed to the Project Planner prior to the hearing.
- If you are going to attend virtual hearing using your phone or electronic device, please download the Cisco Webex application.

Checking into a Virtual Public Hearing:

- If using a computer to access the hearing, enter the meeting link into your browser and click enter. Click the "Join Now" link to join the meeting.
- Another way to access the meeting from a computer is to navigate to https://kittitascounty.webex.com, enter the Meeting Number into the "Join a Meeting" box, and then click the "Join" link.
- You can also access the meeting by calling the dial-in phone number and entering the meeting number into your phone.
- 4. applicant and/or the County may elect to respond to any such comments in writing
by 5:00 p.m. on the second day after the hearing.
